Roadmap for simplifying the CAP legal framework to reduce burden on farmers and national administrations

Building on the 2024 simplification of the Common Agricultural Policy (CAP) for the period 2023-2027 and drawing from the experience of two full years of implementation, the Commission is proposing a comprehensive set of actions aimed, on the one hand, at reducing the burden on farmers and national administrations, and on the other, at steering the policy along the pathway set out in its Vision for Agriculture and Food¹.

A package of amendments to the CAP Strategic Plans' basic legislation, adopted on 14 May 2025, delivers simplification of on-farm requirements, better recognition of diverse farming practices such as organic farming, streamlined support for small and medium-sized farms, measures to boost competitiveness, including enhanced access to financial tools, and increased Member States' flexibility in managing their CAP Strategic Plans.

Complementing this initiative, the Commission started or will soon start revision of the CAP secondary legislation bringing additional elements to the simplification package including for organic farming. To help Member States in making the best use of the CAP opportunities and flexibilities, the Commission will support implementation by national authorities including by organizing exchanges of best practices.

This roadmap outlines the main actions planned, their instruments and indicative timeline.
